2022 LEGISLATIVE NOTES

The seventh week of session is complete. Your Association, like many others, was very busy this week at the Capital. This week contained Crossover Day which took place on Wednesday, February 23, 2022. Contrary to most lobbyist and legislators thinking, Crossover Day ended at more reasonable times with the Senate ending at approximately six o'clock PM and the House finishing up closer to seven o'clock PM.

Your Association continued to monitor legislation of interest during the week. As you will recall, your Association has been following **SB 40**, An Act to establish safety standards regarding biogas gathering lines. The Governor signed this bill into law on February 23, 2022. Another bill worth mentioning again is **SB 126**, An Act to require closure of litigation over the recreational use of nonmeandered waters. After debate on the Senate floor, this bill failed to pass by a vote of 2 yays and 33 nays.

Your Association had much success at the Capital this week. First, **HB 1306**, An Act to make an appropriation – approximately \$50 million – to rural access infrastructure funds and to declare an emergency, was heard on the House floor during Crossover Day. There were few questions and no debate, resulting in the bill passing by a vote of 66-3. The bill has now been referred to Senate Appropriations and scheduled to be heard on March 1, 2022. Next, **HB 1155**, An Act to revise the compensation for a township board member overseer, passed the House floor last week by a vote of February 62-5. It is now scheduled to be heard today (February 25,2022) in Senate Local Government where I will again will have testified as the primary proponent.

Finally, **HB 1156**, An Act to revise provisions regarding weed removal along highways, was heard in House Ag and Natural Resources on Tuesday. After testifying in favor, the bill passed out of committee by a unanimous vote. It has now been referred to Senate Transportation.

As has been the case the past few weeks, it was a successful and encouraging week for your Association at the Capital. While the legislature is arguably "over the hump" with Crossover Day being over, there is still much work to do. I will continue to stay in touch with your Association leadership to continue this work in the best way possible.


